Sub : Assignment Sanction of Rs. 5,34,60,000/- (Rupees Five Crore Thirty Four Lakh Sixty Thousand only) towards payment to Central Tool Room, Ludhiana (CNA) for Engagement of Legal & Secretarial resources (HR) for MSEFCs in the States/UTs and under RAMP during the Financial Year 2025-26 - Reg.

Sir,

I am directed to convey the Assignment Sanction of the President of Rs. 5,34,60,000/- (Rupees Five Crore Thirty Four Lakh Sixty Thousand only) under RAMP National (EAP) "Grants-in-Aid General" Head (2851.00.102.99.15.31) towards making payment to Central Tool Room, Ludhiana as Central Nodal Agency (as CNA) under TSA Model-1A towards Engagement of Legal & Secretarial resources (HR) for MSEFCs in the States/UTs during the Financial Year 2025-26.

2. PAO (MSME), New Delhi may assign the Sanction Amount of Rs. 5,34,60,000/- (Rupees Five Crore Thirty Four Lakh Sixty Thousand only) to Central Tool Room Ludhiana and further Central Tool Room, Ludhiana would be giving assignment/ drawing limits to SAs of respective States/UTs. SAs will be using this assignment / drawing limit for Engagement of Legal & Secretarial resources (HR) for MSEFCs in the States/UTs as per break up tabulated below:

- One Human Resource (Legal) - at a salary of Rs.80,000 pm and
- One or two Office/Secretarial resources (within a cost of Rs. 40,000/- per month for one or two resources, as the case may be).

4. States/UTs can utilize this fund to meet all expenditures for Engagement of Legal & Secretarial resources (HR) for MSEFCs (as per enclosed annexure) in the States/UTs.

5. The States/UTs must follow principles of accountability and procedures of financial discipline and administrative due diligence, as laid out in the GFR, 2017.

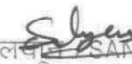
6. Central Tool Room, Ludhiana would be giving assignment/ drawing limits to SAs of respective States/UTs after submission/upload all requisite documents on MIS portal. CTR, Ludhiana has been nominated as CNA vide letter dated 13.9.2022 for Raising and Accelerating MSMEs Performance (RAMP) Scheme (Copy of the order enclosed for reference). The Ministry of Finance, Department of Expenditure's O.M. F.1(18)/PFMS/FCD/2021 dated 9.3.2022 (Copy enclosed).

7. The receipt of this letter may kindly be acknowledged and action taken may be intimated to this Ministry. CTR Ludhiana will also submit the adjustment bill for 5,34,60,000/- after allocating the amount to SAs of the States/UTs as listed in Para 2 above.

8. SO/DDO of the office of the M/o MSME will act as Drawing and Disbursing Officer for this sanction.

9. The progress of the scheme would be monitored by the M/o MSME.

10. The expenditure involved will be met out from the budget provision (BE) for Raising and Accelerating MSMEs Performance (RAMP) States (EAP) and shall be debited in **demand No. 68** of Ministry of Micro, Small and Medium Enterprises for the Financial Year 2025-26 as follows:
